

St. PAUL JCC COVID EXPOSURE RESPONSE

CONFIRMED CASE

Positive Case of COVID-19 Reported by:

- **Member who visited the JCC**
- **Staff who has worked in the building**
- **ECC participant**
- **ECC Teacher**
- **Club J @ Camp Butwin Staff/Participant**

ACTION PLAN (BASELINE):

- If exposure was within 48 hours, the exposed area and any areas on the same air handling system will close down until 48 hours from time of exposure.
- If exposure was more than 48 hours ago:

Fitness Facilities Exposure

- Infected person is asked to quarantine for at least 10 days from date of onset of symptoms and be symptom free for at least 24 hours without medication before they can return to the JCC
- Fitness Facilities will remain open
- The ECC will remain open

ECC Exposure

- The classroom of the infected child will be closed; parents of that classroom must immediately pick up their children; siblings of the infected person must also leave immediately
- The infected child is asked to quarantine for at least 10 days from date of onset of symptoms and be symptom free for at least 24 hours without medication before they can return to the JCC
- All other participants in the exposed classroom are asked to quarantine for at least 14 days from date of last exposure and be symptom free before they can return because symptoms can develop anywhere from 2-14 days after exposure.
- The rest of the ECC will remain open
- Fitness Facilities will remain open

Club J Exposure

- Entire group of the infected child will be closed; parents of that group must immediately pick up their children; siblings of the infected person must also leave camp immediately
- The infected child is asked to quarantine for at least 10 days from date of onset of symptoms and be symptom free for at least 24 hours without medication, and provide documentation of a negative COVID-19 test before they can return to the JCC
- All other participants in the exposed group are asked to quarantine for at least 14 days from date of last exposure and be symptom free before they can return because symptoms can develop anywhere from 2-14 days after exposure.
- The rest of camp will remain open
- Other JCC Facilities will remain open

DIRECT EXPOSURE

Direct Exposure to positive case reported by:

- **A person who had a one-time exposure to a confirmed case**
- **Household members of a confirmed case**

One-time exposure

- Exposed person is asked to quarantine for 14 days from the date of exposure and be symptom free before they can return to the JCC because symptoms can develop anywhere from 2-14 days after exposure.
- Reporter is asked to inform JCC of any changes (JCC staff will follow up regularly)

In the household exposure

- All members of the infected person's household are asked to quarantine for at least 14 days from date of last exposure and be symptom free before they can return because symptoms can develop anywhere from 2-14 days after exposure.
- If person is able to avoid further close contact* with the infected person, they can return after 14 days
- If the person is unable to avoid continued close contact* with the infected person, they are asked to quarantine for 14 days from the date of last contact
- Reporter is asked to inform JCC of any changes (JCC staff will follow up regularly)
 - * Close contact: You were within 6 feet of someone who has COVID-19 for at least 15 minutes; you provided care at home to someone who is sick with COVID-1; you had direct physical contact with the person (touched, hugged, or kissed them; you shared eating or drinking utensils; they sneezed, coughed, or somehow got respiratory droplets on you

EXPERIENCING SYMPTOMS

Report of a staff member or participant that is experiencing COVID-19 symptoms

- **SYMPTOMS:** New onset cough or shortness of breath by themselves OR at least 2 of the following: fever (100.4 or higher), headache, chills, muscle pain, sore throat, loss of sense of smell or taste, and gastrointestinal symptoms of diarrhea, vomiting, or nausea.
- Upon onset of symptoms the individual is asked to quarantine their household and encouraged to immediately get tested for COVID-19
- A person may return to the JCC after a minimum 10-day quarantine and at least 24 hours free of symptoms with no medication; OR
Provide written documentation from a Health Care Provider confirming an alternative diagnosis, or another explanation for the symptoms
